1. **Introduction & Objectives:**

Mishra Dhatu Nigam Limited (MIDHANI) is a Public Sector Enterprise under Ministry of Defence and is located in Hyderabad, Telangana, India. It has wide manufacturing facilities for manufacture of armoured steel, low alloy steels, high alloy steels, special steels, stainless steels, super alloys, titanium & titanium alloys in various forms and sizes. MIDHANI desires to identify suitable partner for bullet proofing of military and civilian vehicles. The potential partners need to have adequate infrastructure and exposure to perform following activities: -

- a. Fabricator of vehicle bodies having expertise in structuring the vehicle with bullet proof steel, bullet proof glass and composites.
- b. Other desired activities exposure for manufacturer of automobiles:-
 - i. Operations of laser, plasma and water jet cutting machines and welding operations by using armoured electrodes.
 - ii. Conduct of trials as per Central Motor Vehicle Rules (CMVR) and procedure of Vehicle Research and Development Establishment/Automotive Research Association of India (VRDE/ARAI).

MIDHANI invites application from reputed parties through this EOI. Interested parties shall have its own fabrication facility.

2. **Scope of EOI:**

- a. **MIDHANI shall:-**
 - i. Manufacture and supply the input material in the form of BP Steel, Transparent Armour, Composites and Electrodes and other raw materials as per the requirements to the selected partner.
 - ii. Carry out testing and specification test as per trial directive/requirements.
 - iii. Supply vehicle if required
- b. **Partner (Fabricator) shall:-**
 - i. Undertake complete bullet proofing fabrication work of vehicle.
 - ii. Carry out required modifications/upgradation in vehicle.
 - iii. Participate in all testing and trials.

3. **Roles and Responsibility of the Parties:**

- a. **MIDHANI.**
 - i. Provision of material for bullet proofing.
 - ii. Provisioning of suitable vehicle if required.
 - ii. Trials and testing.
- b. **Fabricator.** Fabricator and MIDHANI shall enter into a MOU for a period of five years. Fabricator to undertake bullet proofing of vehicles as per specifications and requirements at MIDHANI premises or any mutually agreed workplace.

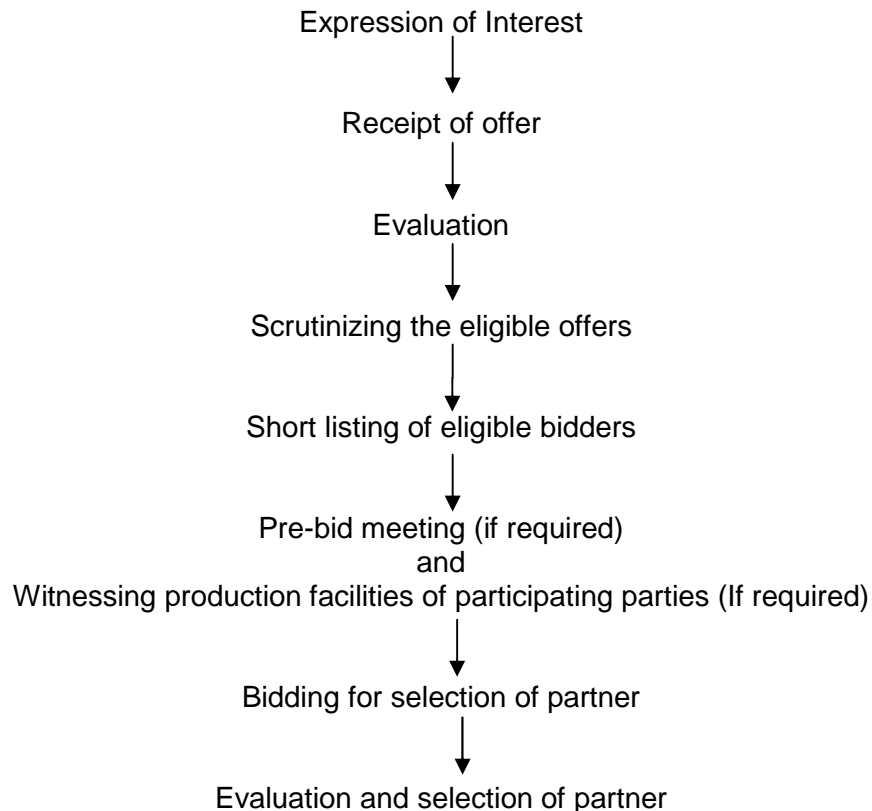
